### **SENATOR CINDY HYDE-SMITH TO HEADLINE 86TH ANNUAL MEETING OF DELTA COUNCIL ON JUNE 4**

Delta Council President, Paul Hollis Rolling Fork, of Chairman and Tom Gresham of Indianola are pleased to announce the 86th Annual Meeting of Delta Council to be held in-person Friday, June 4, 2021, at Delta Úniversity's State Bologna Performing

Arts Center (BPAC) in Cleveland, Mississippi. Keynoting the business session

of the meeting will be U.S. Senator Cindy Hyde-Smith.

"We are very grateful to be able to gather safely once again to continue this long-standing regional tradition of Delta Council Day on the Delta State University campus," said **Paul Hollis**, a producer from Sharkey County

who serves as President. "Delta Council is also grateful that Senator Hyde-Smith will be joining us as the keynote speaker for the business session of the meeting. Her dedication to fundamental legislative issues in the Delta is Sen. Hyde-Smith remarkable, and we look forward to and hope you

will join us in welcoming her."

Senator Hyde-Smith was elected to a six-year term in November 2020, following her 2018 appointment to fill U.S. Senator Thad Cochran's longterm seat. As the first woman elected to represent Mississippi in Washington, D.C., Hyde-Smith serves on four key standing committees in the 117th Congress

- Agriculture, Appropriations, Energy & Natural Resources, and Rules.

She serves on six Appropriations Subcommittees, including: Agriculture, Rural Development, Food and Drug Administration, and Related Agencies; Energy and Water Development; Homeland Security; Interior, Environment, and Related Agencies; Labor, Health and Human Services, Education, and Related Agencies; and Financial Services and General Government, on which she serves as Ranking Member.

### SHERILYN JONES NAMED GOOD MIDDLING COMMUNITY SERVICE AWARD RECIPIENT

**Sherilyn Jones** of Inverness has been named the Good Middling Community Service Award Recipient for 2021 and will be recognized at the 86th Annual Meeting of Delta Council.

Coined after the term "good middling", the highest grade in quality cotton production, the Good Middling Community Service Award recognizes individuals who have sustained significant efforts to promote community and economic vitality in the Mississippi Delta.

"Sherilyn Jones has always

been very involved in the life of her local community and the greater Delta area. Sherilyn has willingly shared her talents and her time, and we are all fortunate and appreciative of her efforts," said Delta Council Arrangements Chairwoman **Irene Long** of Indianola.

**Sherilyn** earned a bachelor's degree in Sociology and Psychology from Auburn University, a Master of Education in Guidance and Counseling from Mississippi State University and a master's degree in Sociology from Delta State University. She has continued educational course work from a variety of universities as well.

She is a longstanding leader with the American Association of University Women (AAUW). During her tenure with AAUW, she served on the College/University National Committee of which she was also the Chair. She was a member of the Legal Advocacy Fund Board, served as Southeastern Regional Director, as well as the AAUW Mississippi State President. **Sherilyn** 



also started the first community college branch of AAUW in the Nation at Mississippi Delta Community College.

In addition to this work, she has moderated several political forums from local mayoral elections to U.S. Representative, Mississippi Governor and U.S. Senator elections.

In the community, **Sherilyn** has served as the first President of Mississippi Women for Agriculture since 2010 and is treasurer for the Sunflower County Humane

Society Board. She is on multiple community boards of directors including the Indianola Literacy Board, Indianola Excel by Five, Indianola Open Air Market, Mississippi Tennis Association, MS Delta Community College Center for Career & Workforce Development Advisory Board, MS Council for the Humanities and the Coalition for Mississippi's Children. She is also a member of the Delta Rockers dance team.

Born and raised in Atlanta, Georgia, **Sherilyn** now resides in Inverness with her husband of 44 years, **Austin Jones**. They have one son, **Andy**, and daughter-in-law **Christy** and two grandchildren. They are members of First United Methodist Church in Indianola where she serves as a youth teacher, office assistant and assists with Bible studies.

In her spare time, **Sherilyn** enjoys playing tennis, traveling, Bible study, tending to dogs and horses, and watching Mississippi State University sports and the New Orleans Saints.

Management, and Trade; Conservation, Forestry, and Natural Resources; and Livestock, Dairy, Poultry, Local Food Systems, and Food Safety and Security, on which she serves as Ranking Member. On the Energy and Natural Resources Committee, Hyde-Smith also serves on three subcommittees, including: Energy; Public Lands, Forests, and Mining; and Water and Power, on which she serves as Ranking Member.

"Senator Hyde-Smith has been a strong advocate for the Delta, engaged and effective in the legislative process, working diligently to improve flood control, economic growth, infrastructure, agriculture and public health in our region," said Gresham, an Indianola businessman serving as Chairman of the organization. "Following the devastation caused by the historical 2019 Yazoo Backwater Flood, Senator Hyde-Smith has shown her unwavering support of the completion of the pumps for the South Delta by helping secure commitments from the U.S. Army Corps of Engineers and the Environmental Protection Agency. She has also championed policies to support and protect all facets of our largest industry in the Delta - agriculture." As a U.S. Senator, **Hyde-Smith** has

As a U.S. Senator, **Hyde-Smith** has received the Award for Conservative Achievement from the American Conservative Union Foundation and the Spirit of Enterprise Award from the U.S. Chamber of Commerce. **Hyde-Smith** also received numerous awards and honors for her work as a state legislator and champion of agriculture, including the highest grade for a strong pro-business and fiscally conservative voting record from the Business and Industry Political Education Committee.

Prior to becoming a U.S. Senator for Mississippi, **Hyde-Smith** served as the Mississippi Commissioner of Agriculture and Commerce, elected in 2011 and reelected in 2015. Hyde-Smith and her husband Mike have a daughter, Anna-Michael. They reside in Brookhaven and are active members of Macedonia Baptist Church. 

### 18TH ANNUAL SALUTE TO DELTA HONOR GRADUATES HELD IN CONJUNCTION WITH DELTA COUNCIL DAY

#### LT. GOVERNOR DELBERT HOSEMANN TO SERVE AS KEYNOTE SPEAKER

On Friday, June 4, 2021, Delta Council will hold its 18th Annual Salute to Delta Honor Graduates event during the 86th Annual Meeting of the regional organization at Delta State University. The event is slated for 9:00 a.m. on the lawn of the Bologna Performing Arts Center. **Lt. Governor Delbert Hosemann** will be the keynote speaker for the event.

The Honorable **Delbert Hosemann** is serving as the 33rd Lieutenant Governor and previously served as Secretary of State. Under his leadership, the Senate has consolidated workforce development efforts, increased training opportunities for high-skill jobs, and retooled economic development incentives to be competitive and performance-based. In two years, the Legislature has doubled its investment in pre-K, raised teacher pay, increased funding for classroom supplies, and provided every student with a computer or tablet.

Raised in Warren County, Mississippi, Lt. Governor Hosemann has substantial experience in the private sector as a businessman and tax lawyer. He is a former partner of **Phelps Dunbar, LLP.** He received his undergraduate degree in Business from the University of Notre Dame, a law degree from the University of Mississippi, and a Master of Laws in Taxation from New York University. Prior to attending law school, **Lt. Governor Hosemann** served his country in the United States Army Reserve.

Lt. Governor Hosemann's tenure as Secretary of State was marked by several major accomplishments including requiring 16th Section land, a revenue source for public schools, to be leased for fair value. By the end of his third term, the Office raised more than \$1 billion for public education. He was also instrumental in acquiring over 20,000 acres of now public land.

In his spare time, **Lt. Governor Hosemann** is an avid hunter and runner. He belongs to the National Rifle Association and is a past recipient of the NRA's Kirk Fordice Freedom Award. He is also a member of the Delta Wildlife Foundation and Ducks Unlimited. He has completed both the New York Marathon and the Boston Marathon.
